



TERMS AND CONDITIONS

By joining The Girlz Weekend Group (“TGW GROUP”, “TGW”, “we” and/or “our” and/or “The Founders” and/or “Founders”), you, the member (“you/your”) agree to the terms of this agreement.

BOOKING ACCURACY/LEGAL NAMES

You warrant that you are at least 21 years of age and possess the legal authority to enter into this agreement and to make travel bookings with TGW GROUP by any means. You agree to be financially responsible for The Girlz Weekend trips.

You are required to review all aspects of your statements to verify (but not limited to): member names, mailing address, email address, telephone number, date of birth, pricing, airfare, arrival/departure airports, accommodations, and organized activities on your monthly statements. Please notify TGW GROUP immediately if any omissions and/or corrections are needed regarding the booking details.

DEPOSIT & PAYMENTS

TGW GROUP accepts payments via Square (CASH APP), PayPal, Venmo, Apple Pay, Zelle & Cash Deposits into Regions Bank. By accepting the terms of this agreement, you are consenting and authorizing The Girlz Weekend Group to receive payments from Square (CASH APP), PayPal, Venmo, Apple Pay, Zelle and Cash Deposits into Regions Banks on your behalf using the profile information provided by you at the time of payment. In addition, you assume sole responsibility for, and hereby releases The Girlz Weekend Group from any claims or responsibility for any payment and all monetary damages incurred as a result of identity theft and/or disputation of any payment made to TGW GROUP from Square (CASH APP), PayPal, Venmo, Apple Pay, Zelle and your financial institution.

From time to time TGW GROUP may (at The Girlz Weekend’s discretion) make payment to a Third-Party Supplier for Travel Services on behalf of a member using the TGW GROUP credit card or other payment method. Additional fees may be applied for such a service.

TGW Group will request a **\$50 deposit** when booking your trip. This deposit will be refundable under the following two conditions: (1) Cancellation within 60 days of booking and (2) if the trip is cancelled entirely or postponed. **Monthly payments** should be made on time. Failure to remit payments on a timely basis will automatically put your booking at risk of cancellation. Please contact us immediately, **and in advance** of your payment due date, if you will be unable to meet this obligation. Without limitation, Member(s) voluntarily hold TGW GROUP harmless for cancellation of any booking for late payment.

ACCOMMODATIONS AND ACTIVITIES

IN ADDITION TO THE LIMITATIONS OF LIABILITY SET FORTH ABOVE, YOU AGREE THAT TGW GROUP IS NOT LIABLE FOR ANY DAMAGES ARISING FROM OR RELATED TO ANY AIRLINE TIMETABLE CHANGES, DELAYS, CANCELLATIONS, MISSED CONNECTIONS, MECHANICAL PROBLEMS, INCLEMENT WEATHER, SEATING REASSIGNMENTS, LOST/DELAYED BAGGAGE, SCREENING AND SECURITY DELAYS, REFUSED BOARDING OR FAILURE TO CHECK-IN PROPERLY.

CANCELLATION POLICY

All cancellations after 60 days of booking are subject to a non-refundable **\$50** per person fee imposed by TGW. If you cancel within 60 days of booking, you will receive everything you paid **including** the \$50 deposit. In addition, TGW GROUP will abide by the cancellation policies of the resort, cruise line, etc. and will not be liable for cancellation penalties on individual bookings.

In the event, TGW trip is affected by Force Majeure (natural disaster, acts of Gods, laws and/or restrictions), TGW Group shall be entitled to, and may in their sole and absolute discretion, vary or cancel any itinerary or arrangement in relation to the trip. Payment of any refund by TGW GROUP to you as a result of the non-performance of any obligations hereunder shall remain in its sole and absolute discretion, although TGW GROUP shall use its reasonable efforts to reimburse you where possible including the \$50 deposit.
